- ❖ To explore effective strategies for enhancing the Church's engagement with civil society, government institutions, and international organizations for the betterment of communities.
- ❖ To promote interfaith dialogue and understanding, emphasizing the Church's role in fostering religious harmony and peaceful coexistence.
- ❖ To identify emerging challenges faced by the Church and society and develop actionable recommendations for addressing them.

#### **KEY THEMES DISCUSSED:**

The conference covered a wide range of topics, related to the intersection of faith and societal issues including:

- a. Social Justice and Human Rights: The role of the church in advocating for human rights, promoting equality, and addressing social injustices.
- b. Community Engagement and Empowerment: Strategies for churches to effectively engage with their communities, empower marginalized groups, and contribute to sustainable development.
- c. Ethical Leadership and Governance: Discussions on the responsibilities of church leaders in promoting ethical governance, transparency, and accountability in society.

- 5. **Bishop Dr. David Quartelai Quartey**, theologian, administrator and human resource management expert, presented a paper titled "Women Empowerment for Societal Transformation"
- 6. **Rev. Assoc. Prof. Joseph Maren Sampson**, Rector, College of Peace and Reconciliation Studies, presented on "Christian Education and the Teaching of Peace and Security in African Context".

# ATTENDEES AND NETWORKING:

The conference attracted a diverse group of Sixty-Four (64) attendees, including clergy members, scholars, activists, and representatives from non-profit organizations.
